## Public Participation

- Stephanie Hicks spoke of a Pet Health Fair that occurred on September 9, 2017 at Blackhawk Court, she thanked the Board for temporarily lowering the cost of licenses and fees for the event. There were 65 non-compliant pets that were serviced during the event. They are now providing follow-up resources to pet owners which will create less in-take on Animal Services.
- Richard Kunnert, a member of the Winnebago County Mental Health Advisory Committee, spoke of the condition of Key Behavioral Health Services within Winnebago County. Several Key Community Issues are the need for Crisis Intervention, the Lack of In-Patient Services (Particularly children and adolescents), the Lack of Family In-Community Support, the Lack of Outreach and Early Identification and the Lack of Case Management to Maintain Stability for these folks. He asks that the Board Fund the Triage Center.
- Jane Carrell, a member of the Board of Northern IL Tea Party questioned several Budget Conditions associated with the approval/rejection of the Fiscal Year 2018 Annual Budget.
- Anthony Miceli spoke in response to a lack of facts presented at last week's County Board Meeting. He described a number of scenarios regarding incidents which occurred within the County in the last couple years. The responses and positive results of these incidents prove the effectiveness of the Winnebago County Sheriff's Department.
- Tamara Shorter, Vice President of AFSME Local 448 spoke to advocate for those who cannot speak for themselves regarding how the Budget Cuts will affect Public Safety. She is concerned that we don't understand what it means to be without the proper number of Deputies within all County Facilities.
- Edward A. Sadlowski, serving as Council 31 Representative for AFSME, representing Winnebago County Employees, spoke of the public safety needs in our Community, of staffing levels, of two grievances filed, of the wage schedule, and of the rights of AFSME members. He asked that the Board show some real leadership by making the correct decisions.

County Board Member Wilson announced that, due to health reasons, the Tuskegee Airman will no longer be able come to Rockford during Black History Month. He will be looking for another way to honor Black History Month, going forward.

#### **CHAIRMAN'S REPORT**

9. Chairman Haney announced that the County received a Certificate of Achievement for Excellence in Financial Reporting by the Government Financial Officers Association of the United States and Canada, for its Comprehensive Annual Financial Report. He thanked the Finance and Auditing Departments for their work.

He congratulated Goodwill Industries and Sam Schmitz. Recently the Governor of Illinois was in town and they signed legislation about the Excel Center. There are 10,000 people (16 to 24 years old) in our community who do not have a high diploma and are not currently enrolled. This is specialized program that will do a lot of good in our community in the future.

The Chairman thanked the Register Star for their editorial today. None of us like the financial picture in which we are going about making decisions, but in terms of where we're at he did appreciate their comments on the validity of what we're actually looking at. We may disagree on how to go forward, but that is a different point altogether than where we've been and where we're at right now; so thank you to them.

He passed along his thoughts and prayers to the Wright Family (speaking for the entire Board) and wished him a speedy recovery. God Bless him and his family. And thank Stephen for his service to the community.

Board Member Fellars proposed a Budget Amendment to include the following items, seconded by Board Member Crosby.

- Decrease the State's Attorney's Budget Cut from \$300,000 to \$200,000
- Decrease the Public Defender's Budget Cut from \$250,000 to \$150,000
- Use Reserve Funds to off-set this decrease

The motion for the Amendment was approved by a roll call vote of 13 yes, with 7 no votes. (Biondo, Booker, Gerl, Kelley, McDonald, Nicolosi and Schultz voted no.)

Board Member Gerl made a Budget Amendment to include the following items, seconded by Board Member Nicolosi.

- -Reduce Public Safety Budget by 10% instead of 20%, total cut \$2,163,000.00
- -Reduce Judicial Budget by 5% instead of 8.5%, total cut \$539,955.05
- -Reduce the total General Government Budget by \$1,063,000.00 (includes proposed cuts of \$425,000)

- Use an additional \$750,000.00 from Host Fee fund to Offset Capital Needs in Various Departments
- Use \$1,642,045.00 (est. amt.) from Reserve Funds to Accommodate for any Additional Deficit Shortfalls

Discussion by Chairman Haney, CFO Paschal, Board Members Hoffman, Biondo, McDonald, Fellars, Jury, Booker, Wilson, Goral, and Nicolosi. Motion failed by a roll call vote of 7 yes and 13 no votes. (Board Members Biondo, Boomer, Crosby, Fellars, Fiduccia, Goral, Jury, Kelley, Redd, Salgado, Schultz, Webster and Wilson voted no.)

- 18. With the approval of Fiscal Year 2018 Budget before the Board, discussion continued by Chairman Haney, Board Members Nicolosi, Salgado, Fellars, McDonald and Fiduccia. County Board Member Jury Called the Question, seconded by Board Member Boomer. Motion to Call the Question was approved by a voice vote. With the Fiscal Year 2018 Budget (as Amended) before the Board for approval the Clerk called a Roll Call vote with 12 yes and 8 no votes. (Board Members Booker, Gerl, Hoffman, McDonald, Nicolosi, Schultz, Tassoni, and Wescott voted no.)
