8. Jury left an updated "Hotline" report from County Auditor Crowley on each of the County Board Members desk. Auditor Crowley attended an Operations Committee Meeting to give an update on how the "Hotline" was going. During the meeting several items were found that need to be addressed. Auditor Crowley will attend future meetings to make adjustments to the "Hotline."

# **CHAIRMAN'S REPORT**

9. Rockford Area Visitors and Convention Bureau – Fred Wescott, Board Liaison - Wescott had served on the Rockford Area Visitor Convention Bureau Board and is being reappointed to that position on behalf of the board as a representative leading the Economic Development Committee. Chairman Haney thanked Wescott his leadership.

Revenue Update - Chief Financial Officer Paschal gave a finance revenue update. CFO Paschal prepared an update on the major revenue sources for the County and Finance Committee. The data was based on a span of six months. Further detail was given by CFO Paschal. Chairman Haney thanked Paschal for her good work.

Consolidation Discussion - Chairman Haney discussed the possibility of consolidation with the County Clerk Mullins' and County Recorder's McPherson's offices. This is not a recommendation by Chairman Haney, County Clerk Mullins, or County Recorder McPherson, but will be based on the voters via referendum. Board Member Jury is in favor of this consolidation and suggested a consolidation of the Election Board in an effort to save money.

Highway Update — County Engineer Joseph Vanderwerff discussed the impact on Winnebago County if the failure of the State of Illinois to pass a Budget. On June 14, 2017, the Illinois Department of Transportation notified the County that because of the lack of a State Budget, funding for engineering and construction projects will not be available after June 30, 2017. The notice specifies that this includes both Federal and State funding. MFT funding is provided to the Highway Department by the State of Illinois. We expect that our monthly statutory allocation of MFT funds will be halted. Subject to the approval of the County Board, we are planning on not proceeding with any projects after June 30, 2017 without a State Budget. County Engineer Vanderwerff recommends that we suspend any project associated with MFT Funds or State

Funds going forward until there is a Budget agreement. For more specific information regarding these projects contact Joseph Vanderwerff, County Engineer or Wayne Vlk, assistant County Engineer at 815-319-4000. Jury added because the State of Illinois does not have a budget it will also impact our credit rating.

1% PSST Update – Currently there no updates on the 1% PSST. Chief Financial Officer Paschal is working in gathering information on the history of the 1% tax. The information should be available next week. Chairman Haney thanked CFO Paschal for all of her hard work.

Fusion Center - Chairman Haney met with Winnebago County Sheriff, Gary Caruana and City of Rockford Chief of Police, Dan O'Shea and had a follow up meeting in regards to the financial commitment related to the Fusion Center and partnering with the City of Rockford. After viewing the budget and uncertainties with deficits the decision is up to the County Board. Due to the Budget Chairman Haney recommends holding off on making any decisions until there is a Capital plan. Further discussion by County Board Members, Goral, Schultz, Fellars, and Booker.
